This call for volunteers is to fill three vacancies on the Lunenburg County Accessibility Advisory Committee. One is for a two-year term and two are for three-year terms. You are eligible to apply to be a member of the Lunenburg County Accessibility Advisory Committee if you live in Lunenburg County. This includes the Municipality of the District of Chester, Municipality of the District of Lunenburg, Town of Bridgewater, Town of Mahone Bay, and Town of Lunenburg.

At least one half of the members of the advisory committee must have a disability or represent an organization that represents people with disabilities.

Disability includes a physical, mental, intellectual, learning, or sensory impairment—including an episodic disability—that, in interaction with a barrier, hinders an individual's full and effective participation in society.
